# The Political Affiliations of Candidates in Non-partisan Elections: Pima County 2024

Candidates in non-partisan elections are not nominated by political parties, but a candidate's registered political affiliation is a public record that voters have a right to know. Registration as a member of a political party is generally presumed to be a declaration of support for the principles and goals of that party. The following information is intended as a *supplement* to the information published in the State and County "Publicity Pamphlets" and other such election guides. Note that Fire District elections are omitted. The methods used to compile the information in this table are described on p.3 along with the footnotes.

#### **METHODS AND SOURCES:**

Lists of candidates posted on the Pima County Elections Department's website, on the Arizona Courts' website, in the AZ Secretary of State's Election Guide, and on the Pima County School Superintendent's website were searched in a voter-registration database covering all of Arizona and current as of September 2024, and, where appropriate, in a database of Pima County registrations covering the past five years.

When a candidate's name matches the name on one and only one registration and that registration's address is located in the relevant election district, the registration is presumed to be the candidate's, and the registered party affiliation is noted in the left-hand column of the table. When there is a discrepancy between the names or the addresses, a note is provided below; common nicknames ("Tom" for "Thomas", "Bill" for "William") are not considered discrepancies. Candidates' websites and supplemental information used to assist in identifying candidates were obtained only from reports and/or public records available online and located by web searches on the name & office; citations retrieved in the first two pages of each search were reviewed.

# JPR: JUDICIAL PERFORMANCE REVIEW

The members of the Arizona Commission on Judicial Performance Review, appointed by the Arizona Supreme Court, review various information and vote on whether each judge "Meets" or "Does Not Meet" performance standards. Every judge on this year's ballot was deemed "Meets". Note that **NO statistically valid comparisons and conclusions can be drawn from the survey data tables** reported on the JPR website; self-selected sampling and response rates under 25% make the potential for non-response bias overwhelming.

#### **NOTES:**

- 1. No registration for that name was found; affiliation is presumed from endorsement by "Arizona List", an organization supporting "pro-choice Democratic women running for office in Arizona").
- 2. Note that judges, police, etc. are permitted to redact personal data from public registration records.
- 3. Registration (D) found for Karla Irene Morales but candidate identifies self as Karla Bernal Morales; affiliation presumed as candidate is endorsed by "Arizona List".
- 4. Registration (D) of a variation of listed name ("Catherine" as middle name) was found and identified presumptively as candidate's; candidate is endorsed by "Arizona List".
- 5. Pima County Republican Party's website list of "Registered Republican Candidates" lists him as "Registered PND (Votes R)"; PND stands for "Party Not Designated".
- 7. No registration for that listed name was found; registration was found for variant "Pilar M. Ruiz" at an address associated with owner "Pilar M. Acosta"; registration is presumptively identified as candidate's
- 8. No registration was found for surname "Luna Rose" or "Rose"; registration was found for surname "Luna" at address associated with surname "Rose"; registration is identified presumptively as candidate's.
- 9. No registration was found for any combination of candidate's listed names; Pima County Republican Party's website lists the candidate's name in "Republican Candidates"; member of the Federalist Society.
- 10. Previously registered as Republican; Pima County Republican Party's website lists the candidate's name in "Republican Candidates"
- 11. Previously registered as Republican.
- 12. Multiple registrations were found for that name; additional information from public records and news reports enabled presumptive identification of candidate.
- 13. No registration was found for any combination of candidate's listed names; affiliation cannot be determined from registration records.
- 14. No relevant registration was found for that surname; registration was found for surname "Harris Ortiz".
